IMPORTANT UPDATE ON THE 2024 NJ "ANCHOR PROGRAM"

The New Jersey 2024 Anchor program season has begun. Eligibility and payments for this year's ANCHOR program are based on your 2021 New Jersey residency, income, and age. For that year, homeowners must have had an annual gross income of \$250,000 or less, and renters must have had an annual income of \$150,000 or less to be eligible.
